Item 1: Confirmation of Minutes of the Previous Meeting and Action Taken Report (ATR)

The Chairperson, Dr. Anil Kaushik, opened the meeting by welcoming all members. He presented the minutes of the previous Board of Studies meeting and invited comments.

Dr. Ashok Prem confirmed that no corrections were necessary, and the minutes reflected the discussions and resolutions accurately. The Action Taken Report (ATR) on the previous resolutions was then presented.

After deliberation, the committee unanimously resolved to confirm the minutes and take note of the ATR.

Resolution: The minutes of the previous meeting and the ATR were confirmed and approved unanimously.

Item 2: Review and Recommendation of Changes in Syllabus

The Chair informed the members that suggestions for updating and improving the syllabi had been invited from all faculty members based on the subjects they taught in the current and previous semesters.

Dr. Bharat Kumar Jajra, as proposer of this item, initiated the discussion and highlighted the need for aligning syllabi of B.A. LL.B., B.B.A. LL.B., LL.B., (3-Year), and LL.M. (2-Year)



programmes with the latest Bar Council of India (BCI) guidelines, UGC model curriculum, and evolving legal education trends.

Dr. Ashok Prem suggested that more emphasis be placed on practical application, including the incorporation of legal clinics, moot court exercises, and emerging fields such as cyber law and artificial intelligence in law.

Ms. Pooja Chhimpa emphasized feedback from students and alumni, suggesting integration of interactive methods, internships, and emerging legislation.

After in-depth discussion, it was resolved that the proposed updates and improvements be recommended for implementation from the academic sessions mentioned.

Resolution: Syllabi for the above programmes were reviewed and approved unanimously with suggested amendments.

Item 3: Review and Recommendation for Format of Dissertation

The Chair invited members to review the dissertation format for both UG (B.A. LL.B. / B.B.A. LL.B. - 10th Semester) and PG (LL.M.) programmes.

Ms. Pooja Chhimpa, who proposed this item, suggested a standardized format including a uniform citation style (preferably Bluebook), word limits, plagiarism limits, and submission protocols.

Dr. Ashok Prem supported the idea and added that evaluation rubrics and viva protocols should also be clearly defined and circulated in advance.

The members agreed that a unified dissertation format would enhance academic integrity and improve evaluation quality.

Resolution: The revised and standardized dissertation format was approved unanimously for UG and PG law programmes.

Item 4: Review and Recommendation for Format of Ph.D. Thesis and Synopsis

The Chair introduced the next item regarding Ph.D. Thesis and Synopsis formatting and evaluation criteria.

Dr. Anil Kaushik proposed the adoption of a standardized structure in line with UGC guidelines and university ordinance. He emphasized the inclusion of ethics statements, plagiarism reports, structured referencing, and defined timelines for submission.



Prof. (Dr.) Dipali Gupta suggested incorporating a pre-submission presentation and detailed supervisor certification.

The members discussed best practices from other universities and resolved to adopt a comprehensive format and structure.

Resolution: The standardized structure and guidelines for Ph.D. Thesis and Synopsis were recommended and approved unanimously.

Item 5: Finalisation of Panel of Question Paper Setters (Academic Session 2025– 26)

Dr. Bharat Kumar Jajra proposed a diverse and qualified panel of subject experts from reputed institutions to maintain confidentiality and standard of examinations.

Ms. Pooja Chhimpa recommended the inclusion of external examiners from outside the Bikaner to ensure academic impartiality.

Resolution: The proposed panel was approved unanimously.

Item 6: Finalisation of Panel of External Examiners for Viva Voce (Academic Session 2025-26)

Dr. Ashok Prem proposed a panel comprising senior academicians and practicing professionals with over five years of experience.

Dr. Anil Kaushik recommended preparing a dynamic list to ensure rotation and fairness.

Resolution: The panel for external viva examiners was approved unanimously.

Item 7: Attainment of Course Objectives of All Programmes

Proposed by: Prof. (Dr.) Dipali Gupta introduced to discuss the mechanism and status of attainment of course objectives for:

- B.A. LL.B.
- · B.B.A. LL.B.
- LL.B. (3-Year)
- LL.M. (2-Year)

Discussion:

 Dr. Bharat Kumar Jajra presented the outcome-based assessments, result analytics, and student feedback as indicators.



 Dr. Ashok Prem highlighted the need to map internal assessments, practical, and semester-end results with course objectives.

It was agreed that class mentors will collect and submit semester-wise attainment data using predefined rubrics, to be reviewed by the BOS annually.

Resolution: It was unanimously resolved to institutionalise course outcome attainment tracking from the current semester and report the progress in the next BOS meeting.

Conclusion:

The Chairperson extended gratitude to all members for their active participation and insightful inputs. The meeting concluded with a vote of thanks.

Item No. 1: Confirmation of the Minutes of the Previous Meeting

The Chair called the meeting to order and invited the members to confirm the minutes of the previous meeting of the Board of Studies. After a thorough review and discussion, the minutes were unanimously confirmed and accepted as an accurate record of the proceedings.

Item No. 2: Presentation of Action Taken Report

The report was presented by Dr. Anil Kaushik, Dean-FOLA, who provided a comprehensive overview of the actions that had been executed in line with the decisions taken. Item No. 3: Discussion and Approval of Modification in Syllabi of B.A., LL.B. (Five Year Course) & BBA, LL.B. (Five Year Course 2024-29)

Under this agenda item, the members engaged in a detailed discussion regarding the proposed modifications in the syllabi of the B.A., LL.B. (Five Year Course) and B.B.A. LL.B. (Five Year Course) programs according to NEP 2020. (As mentioned in Annexure I & II)

The rationale behind the modifications was presented, and after a comprehensive exchange of views, the modifications were put to a vote. The modifications were approved by a majority vote, and the Chair noted the decision.



Item No. 4: Approval of Syllabus for Optional/Elective Subjects of B.A., LL.B. (Five Year Course 2024-29) & BBA, LL.B. (Five Year Course 2024-29)

The meeting proceeded to discuss the syllabus for the optional and elective subjects of the B.A., L.L.B. (Five Year Course) programs. Key changes included a reordering of subjects and updates to the syllabus according to the latest circular issued by the Bar Council of India. These modifications aim to ensure that the curriculum remains current and relevant to the evolving legal landscape. The changes are expected to enhance the overall academic structure and provide students with a more comprehensive and contemporary legal education. This initiative underscores the commitment to maintaining high standards in legal education and ensuring compliance with national regulatory requirements.

Item No. 6: Discussion and Approval of the Syllabus for LL.M. Corporate Law Branch

During the meeting of the Board of Studies the discussion and approval of the syllabus for the LL.M. Corporate Law Branch were addressed. The Chairperson presented the proposed syllabus, highlighting core subjects such as Advanced Corporate Law, Law Relating to Foreign Exchange, Corporate Law related to the Banking & Insurance Sector in India, International Trade Law, along with research and dissertation requirements. The Board unanimously approved the syllabus with these amendments

Item No. 7: Other Matters

As per the final agenda item, the Chair invited any additional matters to be discussed, subject to the permission of the Chair. No additional matters were raised at this time.

The Board discussed the implementation of the new criminal codes passed by Parliament in 2023, which are to be applicable in July 2024:

- Bharatiya Nyaya Sanhita (BNS), 2023
- Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023
- Bharatiya Sakshya Adhiniyam (BSA), 2023

Decision:

For the 2023-2028 batch, the following substitutions will be made:

- 3rd Semester (July 2024): Indian Penal Code (IPC, 1860) will be replaced by Bharatiya Nyoyo Sonhito (BNS), 2023
- 4th Semester: Criminal Procedure Code (CrPC, 1973) will be replaced by Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023
- 7th Semester: Indian Evidence Act, 1872 will be replaced by Bharatiya Sakshya Adhiniyam (BSA), 2023 under the subject "Law of Evidence"



Agenda Item 5: Curriculum Revision for B.A., LL.B. & B.B.A., LL.B. (2022-2027 Batch) Decision:

Only the Law of Evidence paper will be updated for this batch:

 7th Semester: Indian Evidence Act, 1872 will be replaced by Bharatiya Sakshya Adhiniyam (BSA), 2023

Agenda Item 6: Curriculum Revision for B.A., LL.B. & B.B.A., LL.B. (2021–2026 Batch) Decision:

No change proposed for IPC and CrPC papers since the students will have already completed those semesters.


