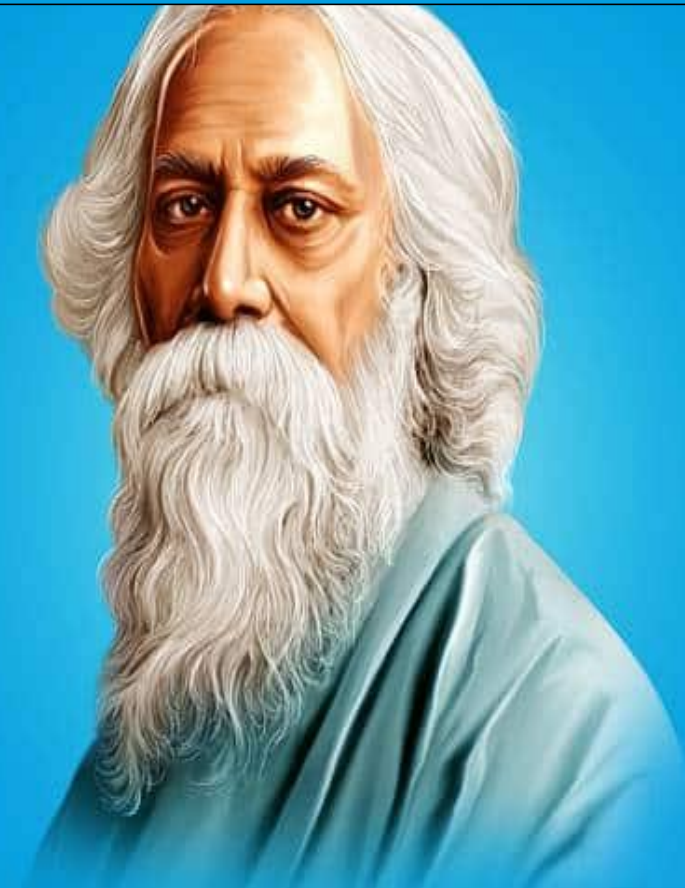
Creative Thinking

sets Fact free from its fetters.

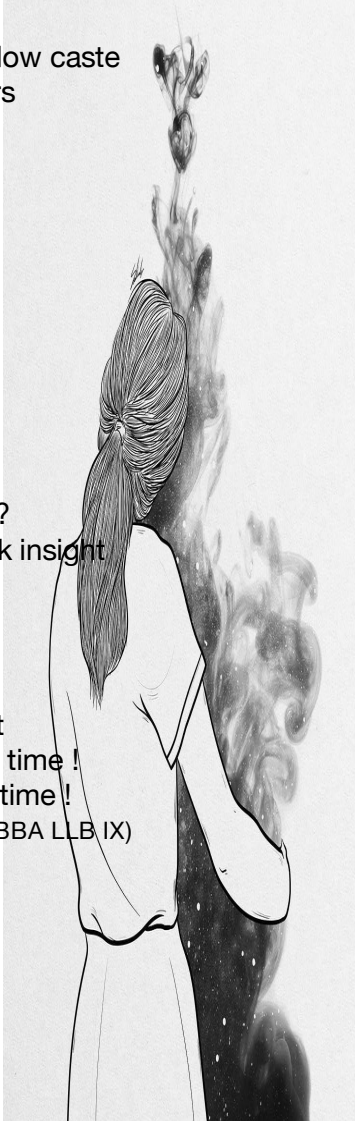
