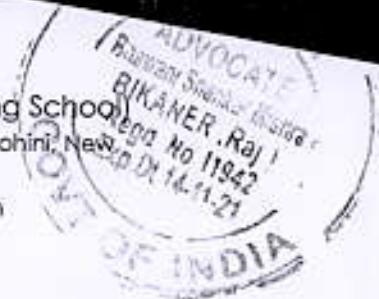

THIS MEMORANDUM OF UNDERSTANDING ("MoU") is entered into on this 21st day of January 2020, by and between Memo Pundits ("MP") and RNB Global University, Bikaner ("the Institution").

MP and the Institute shall hereinafter individually be referred to as a "Party", and collectively as the "Parties", as the context may require.

WHEREAS:

- A. MP is involved in conducting a course titled "Drafting, Editing and Formatting of Moot Court Memorials" ("Course");
- B. The Institute desires to conduct the Course for its students; and
- C. MP and the Institute desire to enter into a long term association for conducting the Course in accordance to the terms and conditions set forth in this MoU.

NOW, THEREFORE, the Parties hereby agree as follows:

1. CONDUCTING THE COURSE

MP and the Institute agree to cooperate, collaborate and organize the Course in accordance with the following terms:

- 1.1. The Course shall be conducted at least once every year;
- 1.2. The dates for the Course shall be finalized mutually by both the Parties, one month in advance;
- 1.3. The Institute shall allow the use of its facilities including auditoriums, conference rooms, lecture rooms, seminar rooms, guest house and other facilities for the purpose of conducting the Course;
- 1.4. The Course shall be conducted within a span of 2-3 days; and
- 1.5. The Course shall be conducted for a minimum of 51 students of the Institute.

2. ADDITIONAL SERVICES PROVIDED BY MP

- 2.1. In addition to providing the Course to the students of the Institute, MP agrees to conduct an yearly memorial screening process for 3 teams of the Institute participating in reputed moot court competitions.
- 2.2. The timings and dates for the memorial screening process shall be mutually decided by the Parties.

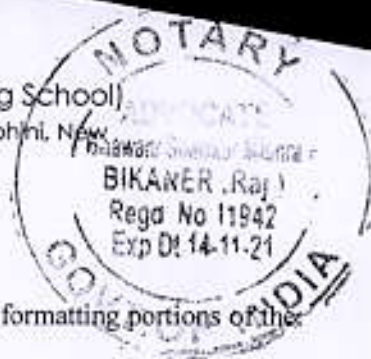

- 2.3. The memorial screening process shall exclusively deal with editing and formatting portions of the memorial.

3. COURSE FEE AND OTHER COMMERCIALS

- 3.1. For the purposes of this MoU, the Course shall be provided at a discounted fee of INR 400 per student.

- 3.2. In the unlikely event that the final number of students attending the Course falls below 51, the applicable fee shall be INR 450 per student.

- 3.3. The fee mentioned above includes provision of additional services as mentioned in Article 2.

- 3.4. The Institute agrees that the Institute will bear the faculty members' out-of-pocket expenses, namely:

- (a) travel by 3 AC train (to-and-fro Delhi);
- (b) accommodation;
- (c) internal transportation to-and-fro railway station and accommodation;
- (d) internal transportation to-and-fro accommodation and the Institute campus;
- (e) breakfast, lunch and dinner;

- 3.5. MP agrees that it shall provide a stamped and signed invoice for the required payment for the Course, 3 days before the first day of the Course.

- 3.6. The Institute agrees that 50% of the payment shall be payable to MP no later than the first day of the Course and the remaining 50% of the payment shall be payable to MP within 7 days from completion of the Course.

- 3.7. The Institute further agrees that any reimbursement of expenses under Article 3.4 shall be completed within 3 working days from the completion of the Course.

4. INTELLECTUAL PROPERTY CONSIDERATIONS

- 4.1. Any intellectual property that arises from work undertaken under this MoU shall be owned by the party or parties responsible for its creation.

- 4.2. Parties may use the counterparty's name and logo for official purposes, including certificates issued to the students, after prior written communication to the counterparty.

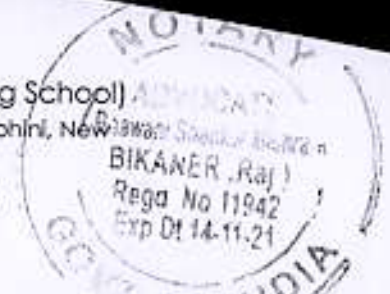

- 4.3. MP will not collect any student data during the Course or after the Course. Any student enquiry should be addressed via Institution's official email id assigned for this purpose during / after the Course.

5. LIABILITY

Except for the loss and damages caused through gross negligence or intent, neither of the parties shall have any liability to each other under this MoU.

6. GENERAL

- 6.1. Each party will maintain a proper record relating to any events organized under this MoU.
- 6.2. Each party will provide necessary information requested by the other to enable the effective operation and performance of this MoU.
- 6.3. Each party will treat information provided by the other as confidential and will not divulge it to any third party without any prior consent of the other party to this MoU.
- 6.4. During the tenure of this MoU, MP shall not conduct the Course in any other law college in Bikaner / Hanumangarh / Ganganagar / Churu / Nagore districts.

7. COMMENCEMENT, TERM, RENEWAL AND TERMINATION

- 7.1. This MoU shall become effective on the date of signing by both the parties and shall remain valid thereafter for a period of one year from the Execution Date.
- 7.2. After expiration of the one year period, the MoU may be renewed, along with mutually agreed alternations, for a future period for as long as the Parties decide.
- 7.3. The MoU may be terminated by either party at any time by giving three months prior written notice to the other party.
- 7.4. Two originals of this MoU have been prepared in English, to be signed by the appropriate officials from the participating institutions. Each of the institutions will retain for its records one original.

8. GOVERNING LAW

This MoU shall be governed by and construed in accordance with Indian law. All the matters arising out of this MoU shall be subject to the exclusive jurisdiction of the courts at New Delhi, India.

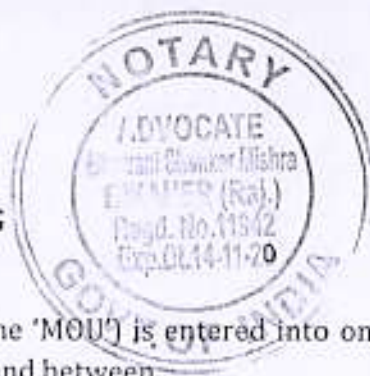

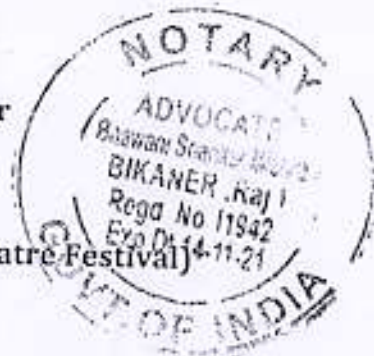
This memorandum of understanding is made on February 04, 2020

PREAMBLE

Recognising the mutual benefits to be gained through a cooperative programme promoting Theatre activities and Managerial Skills, the RNB Global University (hereinafter referred as First party) and Anurag Kala Kendra, Bikaner (Bikaner Theatre Festival) (hereinafter referred as Second party) will enter into this academic and theatre art cooperation agreement.

OBJECTIVES

The purpose of this Memorandum of Understanding is to record formally this mutual interest of the RNB Global University and Anurag Kala Kendra, Bikaner (Bikaner Theatre Festival) in exploring, for a period of ten years following signatures on this MoU, collaborative theatre art, training and capacity building to address art, theatre and training opportunities in Bikaner for the mutual benefits of both parties.

Under this agreement the partner institutions will be able to collaborate in areas that will be of mutual benefit.

IMPLEMENTATION

1. The First Party shall participate through its Faculty Members and the Students in the Bikaner Theatre Festival organised by the Second Party since last many years.
2. The First Party shall not charge any amount for its participation in the Bikaner Theatre Festival.
3. The Second Party shall provide training in administration, Management, Execution of the Festival without any charges to the students participating at the Festival.
4. The Second Party shall provide free food facilities and the certification of participants etc. to all the students from the First Party without any charges.
5. The Second Party shall display the RNB Global University as "Volunteer Partner" in all its promotions & events in which the students from First party shall participate.

6. That the First Party shall be responsible for conveyance of all the participants to and fro between the University and the Festival at its cost.
7. Both Parties undertake to perform their part agreed upon here with good attention, full faith and to their best ability.

DURATION AND TERMINATION

1. This MoU shall become effective on the date that it is signed by both parties and shall be valid for next Ten years.
2. Any changes to this MoU shall be subject to the written consent of both parties.
3. This MoU may be terminated by either party at any time, provided that the party who wishes to terminate gives written notice of its intention at least three months prior to termination.

CONFIDENTIALITY

During the term of this MoU each party shall treat as confidential and shall not disclose to any person the terms of this MoU or any information or materials supplied or made available in connection herewith without the prior written consent of the other party, provided, however the party may disclose such information as required by law or to its professional advisers. This provision shall survive termination or expiration of this MoU.

PUBLIC STATEMENTS

The parties acknowledge the merits of positive publicity, but they recognize that neither party should make any press announcements or public statement about the proposals in this MoU which have not been agreed in advance by the other party.

RNBGU shall indemnify, defend and hold harmless Pfizer, its Affiliates, and its respective officers, Directors, employees and agents (each a "Pfizer Indemnified Party") from and against any and all losses, liabilities, damages, injuries, claims, suits, judgments, causes of action and expenses (including reasonable attorneys' fees, court costs and out-of-pocket expenses) arising out of or relating to any and all actual or asserted third party claims, liabilities, liens, demands, obligations, actions, proceedings, or cause of action of every kind to the extent arising out of related to: (i) claims alleging infringement or improper appropriation or use of any third party's trade secrets or other Intellectual Property Rights (including, without limitation, patents, trademarks and copyrights).
27. Any notice or any other communication shall be in writing and shall be transmitted (a) by postage prepaid registered mail with acknowledgement due or (b) by courier service or (c) by email to the Parties as follows, as elected by the Party giving such notice.



28. All notices or other communications shall be deemed to have been validly served / given on (a) the expiry of 07 (Seven) days after posting if transmitted by Registered Post and / or Speed Post Acknowledgement Due, or (b) the date of receipt if transmitted by courier, or (c) the business date immediately after the date of transmission with confirmed answer back if transmitted by email whichever shall first occur. The parties may, from time to time, change their address for receipt of notices or other communications by giving to the other not less than 30 (Thirty) days' prior written notice to that effect.
29. This MOU / Arrangement constitute the entire understanding between the Parties with respect to its subject matter and merge and supersedes all prior discussions and writings with respect thereto. No modification and/or amendment to this MOU / Arrangement shall be binding upon the Parties unless contained in a writing signed by a duly authorized agent for each respective Party and specifically referring hereto.
30. This MOU / Arrangement may be executed in two or more counterparts, each of which shall be deemed to be an original, and all of which shall together constitute one and the same MOU / Arrangement.
31. The failure of either Party to insist upon the strict observation or performance of any provision of this MOU / Arrangement, or to exercise any right or remedy, shall not be deemed or constructed to be a waiver of such provision for the future and shall not impair or waive any such right or remedy in the future. Every right and remedy given by this MOU / Arrangement to the Parties may be exercised from time to time as often as appropriate. All remedies, either under this MOU / Arrangement or by law or otherwise afforded, will be cumulative and not alternative.
32. This MOU / Arrangement shall apply to, is binding upon, and shall be for the benefit of RNBGU and Pfizer and their respective successors in title. If and to the extent that any term or provision of this MOU / Arrangement is held to be invalid or unenforceable by any court or tribunal in a final non-appealable order, such unenforceable term or provision shall be stricken and the remainder of this MOU / Arrangement shall be unaffected thereby and all remaining terms and provisions of this MOU / Arrangement shall be valid and shall be enforced to the fullest extent permitted by law.
33. The Parties agree that during the terms of this MOU / Arrangement and for one year after the expiry or termination of this MOU / Arrangement, neither Party shall directly or indirectly without prior written authorization, solicit for hire as an employee of the other Party associated with this MOU / Arrangement, provided that the foregoing restriction shall not apply to the non-solicited employment of any person who responds to a recruitment advertisement or posting generally issued to the public.
34. This MOU / Arrangement shall be governed by Indian laws and subject to the exclusive jurisdiction of the Courts at Goa.

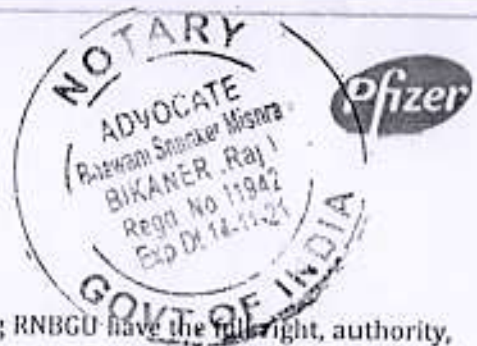



35. The signatories of this MOU / Arrangement representing RNBGU have the full right, authority, permission and approvals for executing this MOU / Arrangement.
36. The rights granted hereunder are cumulative and no exercise or enforcement by either Party of any right or remedy hereunder will preclude the exercise or enforcement of any other right remedy to which either Pfizer or RNBGU is entitled.
37. In the interpretation and construction of this MOU, the Parties acknowledge that the terms hereof reflect extensive negotiations between the Parties and that this MOU shall not be deemed, for the purpose of construction and interpretation, that either Party drafted this MOU.
38. Any and all disputes, controversies and conflicts (hereinafter referred to as "Disputes") arising out of this MOU between the Parties hereto or arising out of or relating to or in connection with this MOU and the performance or non-performance of the rights and obligations set forth herein or the termination or validity or interpretation or implementation or alleged breach of any provision of this MOU shall be referred for arbitration in terms of the Arbitration and Conciliation Act, 1996 or any modifications and/or reenactments thereof. Prior to submitting the Disputes to arbitration the Parties hereto shall mutually resolve to settle the Disputes through mutual negotiation and discussions. In the event that the Disputes are not settled within 30 (Thirty) days of the arising of the Disputes, the same shall finally be settled and determined by arbitration to be conducted by a sole arbitrator in accordance with the Arbitration and Conciliation Act, 1996. The place of arbitration shall be Mumbai and the language used in the arbitral proceedings shall be English. The External Legal Counsel / Auditors of Pfizer will appoint a neutral third party being a Retired Judge to act as the Sole Arbitrator; which appointment shall not be objected by the RNBGU. The arbitral award and decision by the arbitrator shall be in writing and shall be final and binding and shall be enforceable in any court of competent jurisdiction. None of the Parties shall be entitled to commence or maintain any action in a court of law upon any Dispute arising out of or relating to or in connection with this MOU / Arrangement, except for the enforcement of an arbitral award or as permitted under the Arbitration and Conciliation Act, 1996. Pending the submission to arbitration and thereafter, till the tribunal renders its award or decision, the Parties shall, except in the event of termination of this MOU / Arrangement or in the event that relief is granted under the Act, continue to perform their obligations under this MOU / Arrangement.

ANNEXURE

Pfizer's International Anti-Bribery and Anti-Corruption Business Principles

Pfizer has a long-standing policy forbidding bribery and corruption in the conduct of our business in the United States or abroad. Pfizer is committed to performing business with integrity, and acting ethically and legally in accordance with all applicable laws and regulations. We expect the same commitment from the consultants, agents, representatives or other companies and individuals acting on our behalf ("Business Associates"), as well as those acting on behalf of Business Associates (e.g., subcontractors), in connection with work for Pfizer.

Bribery of Government Officials

1. Most countries have laws that forbid making, offering or promising any payment or anything of value (directly or indirectly) to a Government Official when the payment is intended to influence an official act or decision to award or retain business.
2. "Government Official" shall be broadly interpreted and means:
 - i. any elected or appointed Government official (e.g., a legislator or a member of a Government ministry);
 - ii. any employee or individual acting for or on behalf of a Government Official, RNBGU, or enterprise performing a governmental function, or owned or controlled by, a Government (e.g., a healthcare professional employed by a Government hospital or researcher employed by a Government university);
 - iii. any political party officer, candidate for public office, officer, or employee or individual acting for or on behalf of a political party or candidate for public office;
 - iv. any employee or individual acting for or on behalf of a public international organization;
 - v. any member of a royal family or member of the military; and
 - vi. any individual otherwise categorized as a Government Official under law.
3. "Government" means all levels and subdivisions of governments (i.e., local, regional, or national and administrative, legislative, or executive).
Because this definition of "Government Official" is so broad, it is likely that Business Associates will interact with a Government Official in the ordinary course of their business on behalf of Pfizer. For example, doctors employed by Government-owned hospitals would be considered "Government Officials."

The U.S. Foreign Corrupt Practices Act (the "FCPA") prohibits making, promising, or authorizing a payment or providing anything of value to a non-U.S. Government Official to improperly or corruptly influence that official to perform any governmental act or make a decision to assist a company in obtaining or retaining business, or to otherwise gain an improper advantage. 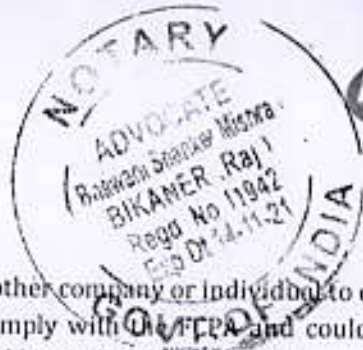

FCPA also prohibits a company or person from using another company or individual to engage in any such activities. As a U.S. company, Pfizer must comply with the FCPA and could be held liable as a result of acts committed anywhere in the world by a Business Associate.

Anti-Bribery and Anti-Corruption Principles Governing Interactions with Governments and Government Officials

Business Associates must communicate and abide by the following principles with regard to their interactions with Governments and Government Officials:

- Business Associates, and those acting on their behalf in connection with work for Pfizer, may not directly or indirectly make, promise, or authorize the making of a corrupt payment or provide anything of value to any Government Official to induce that Government Official to perform any governmental act or make a decision to help Pfizer obtain or retain business. Business Associates, and those acting on their behalf in connection with work for Pfizer, may never make a payment or offer any item or benefit to a Government Official, regardless of value, as an improper incentive for such Government Official to approve, reimburse, prescribe, or purchase a Pfizer product, to influence the outcome of a clinical trial, or to otherwise benefit Pfizer's business activities improperly.
- In conducting their Pfizer-related activities, Business Associates, and those acting on their behalf in connection with work for Pfizer, must understand and comply with any local laws, regulations, or operating procedures (including requirements of Government entities such as Government-owned hospitals or research institutions) that impose limits, restrictions, or disclosure obligations on compensation, financial support, donations, or gifts that may be provided to Government Officials. If a Business Associate is uncertain as to the meaning or applicability of any identified limits, restrictions, or disclosure requirements with respect to interactions with Government Officials, that Business Associate should consult with his or her primary Pfizer contact before engaging in such interactions.
- Business Associates, and those acting on their behalf in connection with work for Pfizer, are not permitted to offer facilitation payments. A "facilitation payment" is a nominal payment to a Government Official for the purpose of securing or expediting the performance of a routine, non-discretionary governmental action. Examples of facilitation payments include payments to expedite the processing of licenses, permits or visas for which all paperwork is in order. In the event that a Business Associate, or someone acting on their behalf in connection with work for Pfizer, receives or becomes aware of a request or demand for a facilitation payment or bribe in connection with work for Pfizer, the Business Associate shall report such request or demand promptly to his or her primary Pfizer contact before taking any further action.

Commercial Bribery

Bribery and corruption can also occur in non-Government, business to business relationships. Most countries have laws which prohibit offering, promising, giving, requesting, receiving, accepting, or agreeing to accept money or anything of value in exchange for an improper business advantage. Examples of prohibited conduct could include, but are not limited to, providing expensive gifts, lavish hospitality, kickbacks, or investment opportunities in order to improperly induce the purchase of goods or services. Pfizer colleagues are not permitted to offer, give, solicit or accept bribes, and we expect our Business Associates, and those acting on their behalf in connection with work for Pfizer, to abide by the same principles.

Anti-Bribery and Anti-Corruption Principles Governing Interactions with Private Parties and Pfizer Colleagues

Business Associates must communicate and abide by the following principles with regard to their interactions with private parties and Pfizer colleagues:

- Business Associates, and those acting on their behalf in connection with work for Pfizer, may not directly or indirectly make, promise, or authorize a corrupt payment or provide anything of value to any person to influence that person to provide an unlawful business advantage for Pfizer.
- Business Associates, and those acting on their behalf in connection with work for Pfizer, may not directly or indirectly, solicit, agree to accept, or receive a payment or anything of value as an improper incentive in connection with their business activities performed for Pfizer.
- Pfizer colleagues are not permitted to receive gifts, services, perks, entertainment, or other items of more than token or nominal monetary value from Business Associates, and those acting on their behalf in connection with work for Pfizer. Moreover, gifts of nominal value are only permitted if they are received on an infrequent basis and only at appropriate gift-giving occasions.

Reporting Suspected or Actual Violations


Business Associates, and those acting on their behalf in connection with work for Pfizer, are expected to raise concerns related to potential violations of these International Anti-Bribery and Anti-Corruption Principles or the law. Such reports can be made to a Business Associate's primary point of contact at Pfizer, or if a Business Associate prefers, to Pfizer's Compliance Group by e-mail at corporate.compliance@pfizer.com
