# DIRECTIVE PRINCIPLES OF STATE POLICY

Article 35 to 51 of the Constitution lays down the DPSP or the Directive Principles of State Policy. The have been borrowed from the Constitution of Ireland.

DPSPs can be defined as ideals which are to be kept in mind by the state while formulating its policies and enacting laws. They seek to establish economic and social democracy in the county. However, they are ideals which are not-justiciable by the courts. These DPSPs are categorized into the following types:

- Gandhian Principles principles based on Gandhian ideology used to represent the program of reconstruction enunciated by Gandhi during national movement.
  - Articles under this principle are: 40, 43, 438, 46, 47, 48
- Socialistic Principles the principles which promote the welfare of the people and aims at providing social, economic and
  political justice and set the path towards the welfare state.
  - Articles under this principle: 38, 39, 39A, 41, 42, 43, 42A, 47
- Liberal-Intellectual Principles these principles reflect the ideology of liberalism, i.e., a philosophy that promotes
  individual rights, civil liberties, democracy and free enterprise.
  - Articles under this principle are: 44, 45, 48, 49, 50 and 51

## MAGNA CARTA

A charter is a document granting certain specific rights, powers, privileges or functions from the sovereign power of the state to an individual, corporation, city or other unit of local organization. One of the most famous charters, is the Magna Carta Libertatum also known as the Great Charter of freedoms. It is the first ever "written constitution" in European history. This royal charter of rights was agreed to by King John of England at Runnymede, near Windsor.

First drafted by Arch bishop of Canterbury, Stephen Langton, it was made to make peace between the King and a group of rebel barons. It promised the protection of church tights, protection of barons from illegal imprisonment, access to swift justice, and litation on feudal payments to the Crown. One of the charter's 63 clauses tasked the barons with choosing 25

representatives to serve as a "form of security" ensuing the preservation of the rights and liberties that have been enumerated. However, it was later annulled by Pope Innocent III, leading to the First Barons' War. The then King's grandson, Edward – I, in 1297 confirmed the charter as a part of England's statute law. Prominent jurists like Sir Edward Coke used Magna Carta extensively in the early 17th century in arguing against the divine rights of kings propounded by the Stuart Monarchs.

The charter declared the sovereign to be subject to the rule of law and documented the liberties held by "free men". The enduring influence of Magna Carta comes not from its detailed expression on feudal relationship between lord and subject, but from more-general clauses which can be used for one's own protection. The right to petition and habeas corpus and the concept of due process are all derived from Magna Carta, which also is a forerunner of Parliament, the peclaration independence, U.S. Constitution and the U.S. Bill of Rights.

There are four extant original copies of this charter of 1215. Two of them were held by the cathedral churches in which they were originally deposited – the Lincoln Cathedral and the Salisbury Cathedral, and two others in British Library in London.

# ROLE OF JUDICIARY IN COVID-19 PANDEMIC

Judiciary is considered as the third very important pillar in our democracy. Judiciary is the guardian of an individual's rights, a protector of the constitution and a promoter of peace in the country, which helps maintain a good administration in the state.

The people of our nation are petrified to another extent. Death and destruction are all that can be seen around us. Amidst this chaos, the Indian judiciary has been a saviour of all. And amidst the chaos, where the government machinery seems dysfunctional, the High Courts and the Supreme Court of the country have step-up to restore order in the country and have made the welfare its citizen at their priority.

Allahabad High Courts' division bench after holding that it is their constitutional duty to save the innocent and to break the criain of COVID-19 pandemic said that people are to be restricted from going outside their homes for a week. The court further stated that it'd be a mockery of the government that they had fail to counter the pandemic even after a long year of learning. The court instructed the closure of institutions and restriction on public d administration in the state.

The division bench of Delhi High Court has expressed that the lives of the people take priority over everything else. The bench had issued an order to the GNCTD to file an affidavit regarding the deaths that have taken place due to the non-availability of oxygen. The bench also asked the Delhi Government to file an affidavit providing the status of liquid and gaseous oxygen refillers, and that the oxygen re-fillers to provide data relating the same on government portals. The Court had also directed that if any oxygen re-filler didn't provide the relevant data, a strict action would be taken against them by both the government and the court. Moreover, the court has also orally ruled that it is the duty of the state to compensate people dying due to the shortage of oxygen.

It has not gone unnoticed by anyone that the prisons of our country are overcrowded with inmates. As of April 7, the total number of inmates in three prisons, names the Tihar, Rohini and Mandoli jails were 17,285 against the total capacity 10,026. A plea was filed by Shobha Gupta before the division bench of Delhi Hight Court for which sought response from the Centre, the Delhi government, and the prisoner authorities to temporarily release the prisoners involved in non-heinous crimes on bail or parole in view of the unrelenting surge in COVID-19 cases. The court has issued a notice to seek response from the Ministry of Law and Health, the government, the police and the office of Lieutenant Governor and the Director General of Prison.

Madras High Court's division bench stated that public health is of paramount importance to all. The court in the case criticized the incidents that have occurred during the elections and stated that it is distressing those Constitutional authorities must be reminded at the importance of public health. The situation is now of one's survival and protection of the citizens, and everything else comes thereafter.

Moreover, Justice DY Chandrachud while hearing the suo moto case pertaining COVID-19 issue has observed that the Central Government has a special responsibility towards the nation's capital Delhi. The Supreme Court in this issue was hearing the Solicitor General on the issue of oxygen shortage across the country. The court addressed plethora of issues which the citizens are facing due to shortage of medical facilities.

Another important issue addressed by the Supreme Court was relating the immunization policy. The court had urged centre to not leave the vaccine pricing to the manufacturers. It further said the centre to use its power under section 92 and 100 of the Patents Act for compulsory licensing of the vaccines. The Supreme Court further observed that vaccine manufacturing is publicly funded and hence are public goods and the centres must buy full doses of vaccine. It also asked the government to give an explanation to the rationale behind the different pricing regarding the vaccines which are sourced by the tolor government on one end and the States on the other.

In these tough times, the courts have taken control over everything and have started to make the government accountable for their actions. The courts have today become the custodian of its citizen and have once again proved their importance in the country. They've in true sense proved that they are here to protect their people.



# FOOD SAFETY AND STANDARDS AUTHORITY OF INDIA

Food Safety and Standards Authority of India (FSSAI) is a statutory body established under the Ministry of Health & Family
Welfare, Government of India. It was established by Former Union Minister Dr Anbumani Ramadoss, Government of India on 5
August 2011 under Food Safety and Standards Act, 2006 which is a consolidating statute related to food safety and regulation
in India. The FSSAI is headed by a non-executive Chairperson, appointed by the Central Government, either holding or has held
the position of not below the rank of Secretary to the Government of India.

The FSSAI consists of a chairperson & 22 members. The FSSAI has its headquarters at New Delhi. The authority also has 6 regional offices located in Delhi, Guwahati, Mumbai, Kolkata, Cochin, and Chennai. FSSAI is responsible for setting standards for food so that there is one body to deal with and no confusion in the minds of consumers, traders, manufacturers, and investors. Rita Teaotia is the current Chairperson for FSSAI and Shri Arun Singhal is the current Chief Executive Officer for FSSAI.

The following are the statutory powers that the FSS Act, 2006 gives to the Food Safety and Standards Authority of India (FSSAI).

- i. Framing of regulations to lay down food safety standards
- ii. Laying down guidelines for accreditation of laboratories for food testing
- Providing scientific advice and technical support to the Central Government
  - iv. Contributing to the development of international technical standards in food
  - v. Collecting and collating data regarding food consumption, contamination, emerging risks, etc.
  - vi. Disseminating information and promoting awareness about food safety and nutrition in India

#### DID YOU KNOW?

Article 39A of the Constitution of India provides for free legal aid legal aid to the poor and weaker sections of the society and ensures justice for all.

#### PRINCIPLES OF NATURAL JUSTICE

Natural justice is an expression of English common law, and involves a procedural requirement of fairness. The word has originated from the maxim jus natural. It is also known has substantial justice or fundamental justice or Universal justice or fair y in action. The principles of natural justice are not embodied rules and are not codified. They are judge made rules and are regarded has counterpart of the American procedural due process.

There are two main principles of this justice system:

- i. 'Nemo judex in causa sua' No one should be made a judge in his own cause and the rule against bias.
- ii. 'Audi alteram partem' To hear the other party or no one should be condemned unheard.

In India the principles of natural justice are embedded in Article 14 and 21 of the Constitution. The principles of natural justice have been adopted by the judiciary to protect public rights against the arbitrary decision by the administrative authorities. At all the stages of the proceedings the main motive of the principles of natural justice is to prevent miscarriage of justice one must keep in mind that in order to held the decision of the adjudicating authorities as valid principles of natural justice (Registral equally important in procedure.

## Paradise Lost




