Item Number 8 (2) to present the action taken on the seventh meeting held on 03-11-2018

The actions taken report on the seventh meeting of the Academic Council was placed before the members. The changes proposed in the syllabi by the Academic Council have been introduced. School of Agriculture has been started last year and this year we got approval for 120 seats for the academic session 2019-20. Academic regulations approved by Seventh AC meetings were implemented in various programmes. The fee committee has approved the format of application form for scholarship and fee for application for the new academic session 2019-20.

Academic Council expressed satisfaction on the report and confirmed.

Item Number 8 (3) Report and Ratification Items




Item No. 6: To suggest the Guest Lectures, workshops seminars etc.
