## Item Number 12(1) Confirmation of Minutes of Tenth Meeting of the Academic Council held on 17-08-2020

The minutes of the Eleventh Meeting of the Academic Council held on 17-08-2020 were circulated among the members of the Academic Council. It was informed to all present members that the office of the Registrar has not received any comment from any member so far hence the proceeding of the previous meeting deemed to be confirmed. Moreover, there being no comments by any member, the minutes of Eleventh Meeting of the Academic council are moved for confirmation and subsequently deemed to be taken as confirmed.

The minutes of the Eleventh meeting of the Academic Council are confirmed.

## Item Number 12 (2) To present the action taken on the Eleventh meeting held on 17-08-2020

The actions taken report on the Eleventh meeting of the Academic Council was placed before the members.

Academic Council expressed satisfaction on the report and confirmed.

#### Item Number 12 (3) Report and Ratification Items

- a. It was informed to all the members that the University Examinations were held as per the UGC Guidelines. In doing so University had to deviate slightly from Academic Calendar 2020-21. All the exams were over till July end.
- b. The University is sincere towards the education of students. Hence during the lockdown period, University guided students regularly about forthcoming Webinars and Workshops of their interest. More than 20 webinar links were provided to students.
- c. It was informed to all the members that University has started processing for publishing its own research journal and applied for the ISSN also.

## Item Number 12 (4) Approval of Academic Calendar for the Academic Session 2021-2022

In order to smooth functioning of the examination process a calendar was prepared and the same was placed before the Academic Council for approval.

Academic Council approved the same.



#### Item Number 12 (5) Discussion on and approval of the Ph.D course in Microbiology:

To promote research culture in University, there is need of opening new Ph.D programs in different subjects. Moreover, Admission cell of the University received queries regarding Ph. D in Microbiology. Hence this matter was put in Academic council for approval. After confirming the availability of required resources, the members approved this program. as introduction of new programs will help in accreditation process also.

## Item Number 12 (6) Discussion on and approval of the recommendations of BoS of all departments.

MOMs of BOS of all the subjects were reviewed by members. BOS of SOA has proposed splitting of the subject Principles of Agronomy and Meteorology of B SC (Hons.)Ag I Semester, into two; Principles of Agronomy in I Sem and Principles of Meteorology in IV Sem. It was approved by Academic Council.

## Item Number 12 (7) To get permission for giving admission on payment seats in B Sc Agriculture:

Dean Agriculture, Prof Rajesh Sharma stated that due to the restriction of JET in B Sc Agriculture admissions, we cannot admit students of other states. Hence there should be provision of certain percentage payment seats in this particular program to benefit students from all over the country. Members proposed to apply for 50% payments from a total of 120 intake capacity.

#### Item Number 12 (8) To approve Event Calendar of all Schools for the Session 2021-22.

Event calendars of all the schools were placed before the Academic Council for approval to ensure smooth conduction of various academic and cultural events. Event calendars have been made according to the online mode having webinars mostly. Prof. Karkara suggested that there should be provision of conversion of online events in to offline mode, when cumpus will reopen, with the consent of Dean of the respective School.

Academic Council approved the same.

#### Item Number 12 (9) Discussion on introduction of new programs in Agriculture:

Prof. Rajesh Sharma proposed for the opening of a new program in School of Agriculture i.e.; B Sc (Hons.) Agribusiness Management. This is an ICAR approved program. The members discussed on



the relevancy and execution of this program. It was recommended that syllabus prescribed by ICAR should be implemented in this program. Academic Council approved this proposal.

## Item Number 12 (10) Discussion on introduction of integrated B Ed program:

The University also wants to introduce integrated B Ed programs in all the schools due to the interest of students, as this will be a job oriented program. The members agreed to this unanimously.

#### Item Number 12 (11) Processing for NAAC accreditation:

Dr. Bhojak appreciated the efforts of University for taking all the necessary steps like; introduction of new programs. Dr. Bhojak suggested for having more of MOUs and collaborations for improving research activities. He further suggested that POs, PSOs and COs should be made according to Criteria 7 of SSR. University should develop incubation and innovation centre also.

#### Item No.1: Confirmation of the minutes of the meeting held on 24th January 2020

Registrar, Ex-Officio Secretary of the Board of Studies informed the house that the minutes were circulated earlier and that no comments were received. The minutes are therefore moved for confirmation. The members then confirmed the minutes.

### Item No.2: Action Taken Report on the Minutes of meeting held on 24th January 2020

The house was informed that for reporting of summer training for both BBA and BCom programs, the university has created the format of weekly reporting on Learning Management System(LMS) of the university portal and distribution of marks was suitable for students.

#### Item No. 3: Reporting Items:

- a) The Board also reviewed the finalised Guidelines for Mini Project (BBA) and Final Project (MBA) and approved them.
- b) The Syllabus of course Goods and Sales(GST) for all programs such as B.Com, BBA and MBA has been implemented
- c) The new course namely Consumer Affairs has been included for all UG programs as per the directions from the UGC
- d) Vocational training in two courses namely Advanced level of Everl programming and Basic & Advanced SPSS for MBA Program has been implemented by the designated faculty members.

Item No.4: Development regarding Guest Lectures, Workshops and Seminars etc

The members were informed that in spite of the prevailing Pandemic Covid -19, Guest Lectures, Workshops and Seminars were conducted virtually through online mode as per the Academic calendar. Besides domain subject guest lectures by experts since June 2020, other programs like Workshop on Strong Communication Skills, Virtual Student Orientation Program 2020 (1 &2 September 2020), Annual HR Conclave on 27 November 2020, Marketing Seminar on 8 Jan 2021, Case Study Competition on 5 February 2021 etc., were conducted.

## Item No.5: Conduction of Academics and Examination during the Pandemic Covid-19

In compliance of the advisory issued by UGC, Ministry of Health & Family Welfare & and the directions of the Rajasthan State Government for complete closure of education institutes (Schools, Colleges, Coaching institutes, etc.,) as a precautionary measure to deal with the spread of corona virus COVID-19 outbreak, the university was closed and classes suspended till 30th March 2020. The university however started on-line classes since 16th March 2020, and also conducted a mix of online classes, video lectures & home assignments to cover the remaining course. Classes were then conducted through online mode in June 2020 for revision of syllabus and Online examination (open book pattern) in July 2020 for the running even semester for all the programs of SOCM. Further, the university has been conducting classes and examination (open book pattern)through online mode for the students till date and will resume offline classes as per further notification received from the regulatory authorities.

## Item No.6: Summer Internship Program during the Pandemic Covid-19

In the prevailing pandemic Covid 19,in the interest of the students and prevent loss of academics to the students ,the university offered the following additional options of summer internship: An online certificate course or Webinars equivalent to 30-35 hours followed by its evaluation during the end semester exams.

## Item No. 7: Adoption of MOOC, NPTEL online courses

The university curriculum has included NPTEL online courses with a timeline of 4, 8-, or 12-weeks for all the students. An in-person, proctored certification exam (optional) will be conducted at Rs. 1000/- per course and a certificate is provided through the participating institutions and industry, when applicable. The students can take up at least one online course of their interest in lieu of any subject as they can easily transfer the credits so earned by the course taken at SWΛΥΛΜ portal or any MOOC course.

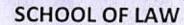
