The Chairperson confirmed the minutes from the 10th meeting held on October 27, 2023.


Item No. 11(2): Review of current code of conduct


Item No. 10(3): Discussion on Organizing Activities to Improve Teaching Skills


Item No. 8(3): Discussion on Awareness of Code of Conduct Policy among Teaching and non Teaching Staff


Item No. 7(3): Orientation on Code of Conduct for New Faculty Members
